

Strengthening measures at the border of the new coronavirus in Japan (stricter confirmation of pre-departure inspection certification: hospitals that can be inspected and certified in Japanese format)

1. The following hospitals in Oman can issue test certificates using the format specified by the Ministry of Health, Labor and Welfare of Japan with the test samples and test methods that the Ministry of Health, Labor and Welfare recognizes as valid.
